About the Event

In an unprecedented three-day event in Berlin, Jean Butler and Colin Dunne reunite to teach select choreography from *Dancing on Dangerous Ground* which had its premiere 25 years ago in London's Drury Lane and went on to a sell-out run in NY's Radio City Music Hall. Described in the New York Times as 'channeling Irish dance into genuine artistic expression' *Dancing on Dangerous Ground* achieved cult status amongst Irish dancers worldwide.

This never-before-offered special event will take place from February 28 – March 2. On Saturday and Sunday, Jean and Colin will teach material and sequences from two of the most popular scenes in the show, The Prologue and The Wedding. These scenes, chosen for their distinct and contrasting choreographic elements, demonstrate Jean and Colin's unique and pioneering approach to expanding Irish dance technique beyond the predominant modes of expression of the time. The earthy-rooted aesthetic of the Prologue in addition to the ebullient intricate celebration of the Wedding sequences allow for participants to experience the full choreographic breadth of this dynamic show.

An intimate gathering on the Friday evening includes a showing of the sole recording of the Radio City production of *Dancing on Dangerous Ground* from 2000. This recently digitized archival recording has never been shown publicly. The recording captures the many changes the show went through in preparation for its North American premiere. A discussion with Jean and Colin moderated by Gyula Glaser will follow the showing with time for Q&A with participants. Light refreshments will be provided.

The Application Process and Fees

This event is open to both amateur and professional dancers, past and present. We look forward to welcoming a diverse group of participants to Berlin for this immersive weekend of dance.

To ensure all dancers possess a suitable level of skills to fully participate over Saturday and Sunday, an Introduction Video is required as part of the application process. A clear understanding and demonstration of timing and rhythm is required as the show includes complex patterns of movement.

All Introduction Videos should include:

- Your name
- A brief comment about why you would like to participate in the workshop
- 16 bars danced in heavy shoe in either Jig, Hornpipe, or Reel time. Please make sure the video is full body shot and that it captures your ability and spirit!
- Professional dancers with an existing show-reel/performance video where they are clearly featured, can submit this as an alternative to dancing 16 bars.
- Anything else you would like to tell us about yourself!

Upload your video to Youtube and select the privacy setting "unlisted". Title your video clearly with your name and include the link in the application form.

Here is a short video guide showing you how to do it.

Due to limited capacity, applications will be assessed on a first come basis.

About Dancing on Dangerous Ground

Dancing on Dangerous Ground, the spectacle Irish dance show inspired by the Celtic legend Diarmuid and Grainne, was created and choreographed by Jean Butler and Colin Dunne, with music composed by Seamus Egan and performed by Solas. The international cast, featuring Butler and Dunne, included twenty four Irish dancers from Ireland, England, Scotland, US, and Canada. The show premiered in the West End's Drury Lane Theatre in December of 1999 and went on to a sellout run in NY's Radio City Music Hall in March 2000. The New York Times hailed the show as 'channeling Irish dance into genuine artistic expression' and New York Magazine claimed 'Dancing on Dangerous Ground, blessedly corrected the more extravagant errors of the earlier shows. Dangerous Ground lets you see dancing. Marvelous dancing, dancing that comes first and foremost.'

About Jean Butler

Jean Butler is an Irish dance artist and choreographer working across theatre, film, sound, and archival practice. Butler's work uniquely bridges the gap between a culturally specific form and a contemporary ideological approach to performance.

Her critically acclaimed production, *What We Hold*, premiered at the Dublin Theatre Festival in 2022 and recently played the Irish Arts Center for a 3-week sellout run in February 2024. Past works have been commissioned and presented by the Abbey Theatre, Baryshnikov Arts Center, Danspace Project, Dublin Dance Festival, Dublin Theatre Festival, Irish Arts Center, Jacobs Pillow, The Joyce, The Kennedy Center, Project Arts Centre, and Seamus Heaney Homeplace, among others.

As Artistic Director of the non-for-profit organization Our Steps, Butler created Our Steps, Our Story: An Irish Dance Legacy Archive with over 200 hours of video and audio resources of never documented solo dances and oral history interviews spanning five countries and seven decades.

Butler has taught extensively at NYU, Princeton University, University of Notre Dame Global Center, and Irish World Academy of Music and Dance at University of Limerick. Butler choreographed and starred in the original productions of Riverdance and Dancing on Dangerous Ground. She is the recipient of many prestigious awards, including TG4's Gradam Ceoil, lifetime achievement award in May 2024.

About Colin Dunne

After making Dancing on Dangerous Ground with Jean Butler, Colin made a bold move and enrolled as a student on the MA in Contemporary Dance Performance at the University of Limerick. Since then, he has worked as an independent dance artist and teacher, collaborating across dance, music, screen, and theatre performance platforms in Ireland and internationally.

His first solo show, *Out of Time* (2008), was nominated for a 2010 Olivier Award for outstanding achievement in dance, and a UK Critics' Circle Award for Best Male Dancer. It toured internationally until 2016 including performances at Biennale de Lyon, Barbican, London and Baryshnikov Arts Centre, NY. His most recent solo show *CONCERT*, based on the music of Irish fiddle player Tommie Potts, received the TG4 Gradam Ceoil Award for Music Collaboration in 2018, and a New York Bessie Award Nomination in 2020.

Other notable collaborations include: Session (2019) with Sidi Larbi Cherkaoui, Whitby (2017) with Joan Sheehy, Edges of Light (2016 commissioned by Music Network), 20 Dancers for the XX Century (2015 Boris Charmatz, at the Tate Museum London), The Turn (2013) composed by Linda Buckley and The Bull (2005) by Michael Keegan Dolan.

Recent performances include: Somewhere In The Body (2022) by Aine Stapleton, Alternatively Terrific and Gentle (2020) by Liz Roche Company, What We Hold (2024) with Jean Butler/Our Steps, and with Martin Hayes, Kate Ellis, and Record producer Jacknife Lee (2023) at the Kennedy Center Washington D.C

As a movement director, his work includes In The Middle of the Fields by Mary Lavin (2023) directed by Joan Sheehy, The Risen People (Abbey Theatre 2013) directed by Jimmy Fay, and Christ Deliver Us (Abbey Theatre 2010) directed by Wayne Jordan.

A passionate teacher, Dunne is an independent thinker when it comes to passing on the tradition. He continues to teach workshops globally and for online platforms and provides mentorship to professional Irish dancers who wish to pursue sustainable careers in the arts. Between 2010 and 2021 he devised and taught modules in both solo making and improvisation for students of Traditional dance at the University of Limerick.

Applications

- 1. Applications open on the 15th of October 2024. The deadline for applications is the 1st of December 2024. They can be submitted only through the application form.
- 2. Applicants will receive a confirmation as soon as their Introduction video is evaluated but no later than the 7^{th} of December 2024.
- 3. Please note that the Event has a maximum capacity of 30 participants. In case of larger interest, a waiting list will be created.

Payment and Cancellation Policy
